Hollywood Elementary offers several opportunities for a broad range of stakeholders (including parents, school staff and community members) to be involved in the examination of relevant academic data to understand needs and root causes. These classes include, but are not limited to Family Portal classes, Literacy Night, SCHOOLMAX, Technology Night, etc) Second Cup of Coffee, Parent/Teacher Conferences, SPMT Meetings, Collaborative Planning Meetings, Leadership Team Meetings, and Staff Meetings. During the various meetings offered to parents, they will have monthly opportunities to learn about trends and current data in Math, Reading, Science, Social Studies as well as Attendance. The focus for parents will be on what the data says and ways in which they can support their children at home. Parents will also have opportunities to meet monthly with the Admin team to ask questions about the data and to make suggestions and give ideas regarding how school staff can support them at home. For staff, data is shared monthly during collaborative planning meetings, SPMT meetings and Leadership team meetings. Data sets that are analyzed include software data and usage, Math Benchmarks, trended data from DRA, county and teacher created

Stakeholders will be provided the opportunity to give input on the school's Title 1 Plan during multiple events throughout the year. These events include: Back-To-School Night, PTA meetings, and Principal's 2nd Cup of Coffee. During our Principal's 2nd Cup of Coffee meetings and events, parents will have the opportunity to learn about our school SMART goals and provide input on our reform strategies and initiatives within our SPP. During our Community Night and Back- To-School-Night parents will receive an overview of the year's SMART goals and Community activities and events to promote student growth. Additionally parents will have an opportunity to meet with classroom teachers and reflect upon the class learning environment. Student and Parent Surveys will be conducted during the classroom visits to gauge family satisfaction and perception of the coming school year. PTA meetings will take place monthly inviting both family and community members to participate in planning, arranging and participating in various events. A staff representative as well as

administrator will be present to share and clarify information regarding events, data and or Title I updates. During the first PTA meeting parents will get an overview of the school's SPP plan and SMART goals and throughout the year they will receive Principal Report updates on the status of the action tasks within our SPP. Parents will be provided the opportunity to provide feedback on the plan at the end of all sessions where the SPP is discussed. All surveys will be available in soft (online) and hard (paper) copies in order to reach all student families. Additionally, teachers and staff will participate in surveys as well in order to provide a wellrounded, team-informed consensus on our progress towards meeting our SPP goals.

A Parent Orientation will be held prior and during the Back-To-School-Night event on Thursday September 23, 2021 (first quarter of the school year) allowing parents to provide input into our Title I Program. Our staff and parents will spend time during this overview session to review the Home School Compact and Parent Plan and make any changes that are necessary to form better communication and collaboration between the community and the school. We will also discuss suggestions for the Title 1 Budget and receive feedback through the use of parent surveys. These surveys will be available for parents throughout the school year at various events. In addition to providing feedback about the Parent Policy and Home School Compact, they will be able to provide us with information about how parents can support their students at home and what training and workshops we can provide that will meet their needs. We will use this information in adapting the Parent Plan for the future. Upon completion of the plan, it will be shared with parents, via CLASS DOJO in the "School Story," as well as during the monthly PTA meetings.

During September 2021 PD staff will decide upon a common, central location in Google Classroom for parent resources, such as the Parent & Family Engagement Plan and School-Parent Compact. In addition, classroom teachers will share the documents with families via DoJo.

On Tuesday September 14th, the Community Schools Coordinator will speak at our Community Schools Night from 6pm-7pm about new related items for students as well as activities, events, and projects for the community this school year

	Hollywood Elementary School has established a partnership with the University of Maryland in order to increase student learning and parental involvement and to provide a greater educational experience for all students. University of Maryland will continue to provide our school with student interns to be placed in primary and intermediate grades who will work with teachers to promote a safe, healthy, encouraging, and academically challenging classroom. Interns will assist in all aspects of the in-person classroom and provide extra support to students who have academic difficulties. Through our partnership with the University of Maryland students will also have hands-on technology experience with the IT/Technology or Minecraft Coordinator. University of Maryland also provides Parent ESOL classes instructed by a University of Maryland professor where parents have the opportunity to learn English as a second language. In addition to our partnership with UMD, Hollywood ES also receives support and resources through district offices. The ESOL office, SPED Office, Community Schools Office, C&I, and Area Office provides the school with professional
